

CONDITIONS OF ENTRY

1. Information on how to enter and prizes form part of these Conditions of Entry.
2. Entry is open to NSW residents. Employees and the immediate families of the Promoter, participating outlets and the agencies associated with this promotion are ineligible.
3. During the promotional period, an entry will be automatically awarded while making a valid purchase online at www.ticketek.com.au for The Kooks on Monday 5 January 2009 at the Hordern Pavillion.
4. In the event of dispute of identity of a drawn winner, the winner will be the person named in the purchase of tickets through Ticketek.
